### **Rector's Report for Vestry 2012**

Every year we gather at Vestry to review the facts of the past year and plan the initiatives of the year to come. ### Warden's report

It is time for Alison Stortz and Paul Ledas to pass the torch to Anne Baker and Mathias Joost, and give thanks for a wonderful year as your Rector's and People's Wardens.

St. Paul's would not be the vibrant, welcoming place it is without the gifts of Father John and Father Craig, which go far beyond Sunday morning worship, and are too numerous to begin to count here. Their dedication to God and to the people of St. Paul's is the foundation of all that happens here, and we give thanks to God for the many blessings they and their families bring to the church. Sadly, this year we bade farewell to Father Marc and the Torchinsky family as they began a new adventure in Petawawa. We are thankful for all they brought to St. Paul's, and grateful that they are still close enough to visit from time to time. We are blessed to have the on-going contributions of our honorary assistants, Bill Prentice and Sally Gadd, our music directors, Ann Faurbo and Maureen Anderson, our office staff, Lorna Brûlé and Carol Spencer, and our custodian, John Taylor. Our most precious resources, our children, have been blessed beyond measure by the tireless efforts of Allison Brooks and her God Squad team. Special thanks to the co-ordinators of our two main annual fundraising and fellowship events: Mathias Joost (Chicken BBQ); Linda Keech and Nancy Moxley (Christmas Bazaar). And last (but certainly not least!), we wish to thank the dozens of volunteers who put in literally thousands of volunteer hours to keep our building and various ministries running smoothly.

Some very visible changes have taken place this year: the memorial garden is shaping up nicely and will be ready for planting in the spring, the stained glass windows have been installed behind the altar and over the narthex door, and the elevator is now installed and fully operational. Thanks to the efforts of Colin and Danielle Mackenzie and the communications team, St. Paul's has been re-branded - our bulletins, newsletters and website now have a uniform look and feel that was presented at Synod as a model for other churches to emulate. Look up, way up - unexpected repairs to the roof due to weather damage have been completed. The outdoor sign is not yet visible, but the site has been chosen and the planning is still underway. One other not-so-visible, but oh-so-appreciated change: a new sound system has been installed in the sanctuary!

It has been a very enlightening year, with several educational and entertaining opportunities. For the young people, in addition to the weekly God Squad events, we hosted an Ash Wednesday holy day of worship, community service, fun and fellowship that welcomed over 60 youth from several parishes. With our drama group, led by Carl Vincent and comprised of youth from St. Paul's and St. Isidore's churches, 12 FEB 2012 6

we continued the journey with St. Paul. The performance of Roger Jones' musical, *While Shepherds Watched*, was an event to remember! For the young at heart, we offered the study of <u>The Five Love</u> <u>Languages</u>, by Gary Chapman, the Lenten Lunch 'n Learn series with a visit from Rabbi Charlie Popky, the Easter preaching series on Hope, evening discussion sessions with NOOMA videos, a course on Bible Navigation, and the "We Believe" preaching series on the Nicene Creed, which culminated in a tridiocesan event featuring Bishop William Willimon of Alabama. As well, Lewis Kruger Lewis organized the Children of Abraham event with 165 university students from Qatar. If you missed any of these opportunities, we encourage you to join the Wednesday morning Bible study group, attend a Community Alpha Course, or join or start a home study group, and get those educational juices flowing!

As 2011 drew to a close, it seemed as though we would end the year with an operating deficit. On behalf of St. Paul's corporation as a whole, we would like to thank all the members of our congregation who rose to the challenge and prevented this from happening. A heartfelt thank you to you all!

The coming year will bring new challenges, financial and otherwise, but we are confident that the people of St. Paul's, with God's help, will overcome whatever lies in store.

### Report on Synod 2011

It was an honour for me to attend the Synod of the Diocese of Ottawa with Fr. John, Fr. Craig, and the other St. Paul's representatives: Heather Colls, Lynn Williams and Vera Near. The theme of this Synod was from Matthew 13: *"Hear Then the Parable of the Sower..." (Mt. 13:18) – Proclaiming, Nurturing and Growing Together.* 

For those of you who may not have attended Synod (yet!), it is the annual meeting of the 73 parishes within our Diocese, at which our Bishop, John Chapman, delivers his "Charge," (a speech in which he set the short- and long-term goals for the diocese and reports on progress made so far). There were over 300 people present at Synod this year – it's a big crowd!

This year's synod focused on the first 2 of the 5 Marks of Mission: 1. To proclaim the Good News of the Kingdom, and 2. To teach, baptise and nurture new believers.

The other 3, just in case you were wondering, are:

- 3. To respond to human need by loving service;
- 4. To seek to transform unjust structures of society; and
- 5. To strive to safeguard the integrity of creation and sustain and renew the life of the earth.

The Community Ministry Development Committee (headed by our own Fr. Bill Prentice), gave updates on the many projects they are involved with, and showed videos of the work being done at The Well and Cornerstone Women's Shelter. We also learned about a new initiative called The Daily Bread Project, which addresses the issue of child poverty within our diocese. This project is currently educating students about nutrition and providing nutritious lunches to students at the Greater Gatineau Elementary School. Within 20 minutes, the roomful of synod delegates prepared over 400 paper bags with "emergency snacks" to be delivered to two elementary schools in our area. These bags will be given to students who regularly come to school without snacks or lunch. We are all encouraged to consider ways of alleviating child poverty in our own communities.

Francis Christensen, chair of the Stewardship Council (for those who may not know Francis, he is also chair of our own Parish Council), talked about the next steps in a program designed to build a "culture of stewardship in faith, both personally and corporately." During the financial update, which used numbers from 2010, we learned that our diocese with 73 parishes has 23,078 members on parish rolls. In spite of the fact that only 9,123 of the 23,000+ members are identifiable givers, there was a 2.2 percent increase in overall givings.

Another member of our St. Paul's family was recognized at Synod – Heather Colls was elected to the position of "alternate rep" to Provincial Synod (representing the Diocese of Ottawa, not just St. Paul's). Provincial Synod takes place every 3 years – the next meeting will be in October 2012 in Kingston. You may already be aware of the G.I.F.T. Campaign (Growing In Faith Together), a capital campaign to be run jointly by the Diocese of Ottawa and each parish, including St. Paul's. The honorary chair of the GIFT Campaign is former CBC Broadcaster Don Newman, who talked about how important his faith and the Anglican Church are to him, and offered to visit any parish who would like to hear more about the GIFT Campaign. Don Newman is a very interesting speaker – we may want to take him up on that offer.

Like many annual meetings, there were items of business to discuss. Synod has a responsibility to direct the diocese to address issues of human rights. This year there were 2 important motions. The first addressed the issue of stopping the Canadian export of asbestos to developing countries, and the second concerned possibly formally endorsing a document opposing the physical/corporal punishment of children and youth.

In addition to the presentations, there were also 4 workshops:

- 1. GIFT representatives from 2 parishes talked about their campaign journey so far.
- 2. Parish Hospitality discussing how to broaden your parish's visibility in the community. St. Paul's new website was promoted as a model for other parishes.
- 3. Visions and Dreams Brainstorm out of your comfort zone with "fire in your belly." What have you done well, share it with everyone, use the gifts God gave you, be connected and ask yourself what one thing you can do that is life-giving, not life-sucking, and do it! Some handy tools are narrative budgets, mentorships, consultations with community, prayer, etc. Be definite and say, "Tomorrow I will....." Ask yourself 2 questions: 1) what message would you send out if you had a 10 minute radio spot? and 2) would this be accomplishing God's work?
- 4. Serving the World God Loves God is here today and active in the world, He's looking for Leadership on earth. Identify who you are, who your community is, inside and outside your parish, Identify projects that are doable and within community scope; "the community" tends to see "the church" as needy and we need to use all our resources to come to the table as leaders, not do-gooders. Choose partnerships wisely, ones that are a good fit for your parish and work through vestry to single-mindedly get job done.

A definite highlight, for me, was the keynote speaker, Rev. Canon William Cliff, from the University of Western Ontario in London. In 2 speeches (addressing the 2 marks of mission), he opened the parables of the Talents, the Pearl of great price, and the Prodigal Son to me in ways I had never heard before.

Going to Synod is an opportunity to learn about all the great things that are happening just beyond our doorstep, to hear some exceptional speakers, and to be challenged and uplifted in ways you would never expect. If you have any questions, or would like to hear more, please speak to any synod representative.

### Kitchen Care

What a lovely kitchen we have and we strive to keep it clean and tidy. There is a group of **ladies who clean the kitchen weekly and take the laundry home**. We are well equipped but like all kitchens still need a few more items. If you are downsizing please give us a call and see if there is anything we could use or are on the hunt for. The kitchen here at St. Paul's is checked by a health inspector from the City of Ottawa yearly and in this past month passed.

### St. Paul's Chicken BBQ, 2011

This year's chicken BBQ was held on Friday, 3 June under excellent weather. As in past years, the volunteers had a lot of fun and made the whole operation run smoothly. A hearty thank you goes out to all our volunteers without whose effort this event would not have been possible. The quilters were thanked this year for their efforts over many years in packaging the buns and butter, as well as cutting the pies and packaging them.

A heart-felt thank you goes out to all of you who made or brought pies. We had a few extra this year, which was wonderful, especially for those of us who could buy one and take it home after the BBQ. This year a total of 600 half-chickens were sold with a profit of about \$2,100 on revenue of \$6,133.10. With the chickens sold at the door there were no extras.

One change for 2012 will be the price. It has been at \$10 for many years, while the cost of chicken alone has increased almost 50 percent in the last two years. We also hope to see new faces get involved. For our teenagers, this can count as volunteer time towards your high-school credits.

Thank you again to one and all for your support. I hope to be able to work with you again next year and to enjoy some great BBQ'd chicken together.

This is organized and run by a very dedicated group of 20+ parishioners in conjunction with various clergy within Kanata.

Many of the seniors come from area retirement & nursing homes, and some are provided transportation by their homes. We do provide transportation as well to people who live on their own.

Our time is spent together in sharing a time of Christian worship & fellowship with one another.

We are so often blessed to have area musicians, singers & groups who give of their time to entertain us after our worship time in the church. The program starts at 2:00 p.m. and we finish up at 3:15 p.m. in time for the buses & drivers to pick up.

It is a wonderfully blessed time with 20, 30 sometimes even 40 seniors on a regular basis. Some of the volunteers are there every week, some come once a month. Their commitment and joy in their participation is evident every week we gather.

I especially want to give thanks to all who participate in this ministry. The bakers, the kitchen workers, the drivers, and the people who are there to lend a hand in any way are an awesome sign of Gods love to all. The seniors who attend are blessed.

I look forward to another year of compassion, joy & thanksgiving for what St. Paul's is offering to those in our community.

### **PASTORAL CARE**

Under the Broad Group Ministry of Pastoral Ministries there are 4 groups.

### Pastoral Care Team, Healing Prayer Team, Telephone Ministry & Prayer Chain.

Each of these ministries continues to be active groups within the Parish.

Each group operates under the guidance of Fr. John and participates in supporting both him & Fr. Craig in their ministries to the Parishioners of St. Paul's.

The **Pastoral** Team Leader is myself and there are 7 active members on the team. We meet about 8-10 times during the year to discuss, learn and share information. We have attended various events offered by the Ottawa Pastoral Centre and continue to be involved with Fr. John & Fr. Craig. We have all completed the 10 week Pastoral Course offered by the Ottawa Centre.

The **Healing** Team is present on Sunday mornings during the 9:15 & 11:00 service on a regular basis. The Team Leader is Cathleen Reid, and there are about 20 members on the team.

As well as participating every Sunday, the team supports the clergy at 2-3 Healing Services held throughout the year.

The **Telephone** Ministry provides an opportunity for those unable to attend regular worship, to listen to the Sunday worship time on their own telephone.

Heather Colls organizes this ministry, in which she also makes sure the participants receive communion at their home, or hospital bed whichever is the case.

The **Prayer Chain** Ministry consists of individuals who pray for specific people who have asked for specific prayer.

Joan Andrews leads this group in organizing and receiving messages from either the office or parishioners themselves who have requested support by prayer.

Please speak to any of these Leaders to find out more about their Ministries.

St. Paul's is blessed immensely by these committed, compassionate people.

<u>The Kanata Food Cupboard</u> is a registered charity, run by a community board, to serve the people of Kanata by providing emergency food to families in need.

St. Paul's is one of six church groups working on a weekly rotation to retrieve phone calls from the clients to the Food Cupboard and arrange times for pick-up, to pack and hand out the requested orders, and to deliver the food if necessary.

A dedicated group of people regularly volunteer their time to the community through this outreach ministry. The numbers needing this community service continue to grow matching the growth of Kanata itself. This past year we have welcomed several new volunteers. We now have volunteers to take the phone calls from clients and set up the evening appointments for pick up, volunteers to pack the food hampers and greet the clients when they arrive at the Food Cupboard and volunteers who deliver food Tuesday and Friday evenings to clients who are unable to come to the Food Cupboard. I want to thank you all for helping out your community in this way. New volunteers are always welcome. Please contact Carol Fowler should you wish to join our team.

The Kanata Food Cupboard depends on the generosity of the community to provide the food that is given out to the clients. Every grocery store in Kanata has a bin marked '**Donations for the Kanata Food Cupboard'**. If each one of us placed one or two food items into one of those bins each time we went grocery shopping, it would go along way to ensuring that those Food Cupboard shelves were always full. Let us make this a goal for our faith based community in 2012.

### Kanata Stittsville Refugee Sponsorship Group

**Members:** In addition to St. Paul's our members include Stittsville United, Glen Cairn United, Kanata United, St. Thomas Anglican, St. John's Anglican and St. Andrew's Presbyterian.

**Rwandan Siblings:** Led by Kanata United. For several years the KSRSG has provided financial support to four orphaned siblings living in Rwanda, who have family members here in Canada. We are seeking to ensure that they receive an education to prepare them for finding long-term employment. In the past we relied on NuVision, a Canadian charity on the ground in Rwanda, to act as an intermediary and to allocate the funds we sent over. However, the charity has since changed its direction and so we have established a relationship with AMAR: Africa Mission Alliance Rwanda, the organization through whom we now work to provide the assistance to these four individuals. We are currently in our third five year commitment. In order to keep it fair, we have committed to supporting the siblings so they each get 1 post secondary degree.

**Shay Ray and Family:** This family of four are members of the Karen ethnic community were refugees from Burma (Myanmar) living in Thailand who arrived in early 2011. We are sponsoring this family with significant assistance also being provided by family members living here in Ottawa and as such no donations are requested. Our financial support will be completed early in 2012.

**Medhat Asmah Family of 8**: St. John the Evangelist Anglican church organized this sponsorship. The family arrived October 31, and came from EI-Hol Refugee camp in Syria. We responded to the request saying we could provide financial assistance to the amount of \$5,000. Other donations are not requested at this time.

**Maryan Yusuf Ali:** Maryan is a 19 year old orphaned refugee from Somalia presently living in Nairobi Kenya. We have applied to sponsor her and her family members here in Ottawa are committed to provide substantial support. Due to the staggering number of refugee applications from that part of Africa, we believe it may be several years before her claim is processed.

**Other Conversations:** Through the year we have been made aware of others seeking refugee sponsorship. Though we did not pursue any of these sponsorships, we have offered logistical assistance and advice regarding other sponsorship avenues where possible

**Financial Resources:** The KSRSG presently has about \$20,000 in reserves. This would be enough to fulfill our present sponsorship obligations. We receive annual contributions from our seven supporting congregations, and also do fundraising for specific situations when required.

### **Bethesda Renewal Centre**

Ray & Lorna Brûlé stepped down from their Ministry at Bethesda in 2011 and are delighted to announce that the Milne family, Rob, Sherry & Josiah, has taken over. Bethesda, although not an official ministry of St. Paul's; was indeed well supported by the Church for the 11 years the Brûlé's were in residence. Families with Young Children held an outdoor winter afternoon, women from St. Paul's hold their annual winter weekend at Bethesda and members of St. Paul's sit as Board Members and members of their Fellowship. ### The Primate's World Relief and Development Fund (PWRDF or The Primate's Fund Submitted by Philippa Wilson

"As an instrument of faith, PWRDF connects Anglicans in Canada to communities around the world in dynamic partnerships to advance development, to respond to emergencies, to assist refugees, and to act for positive change" <u>www.pwrdf.org</u>

The congregation of St Paul's continues to support PWRDF; responding to emergencies in particular the devastating earthquake and tsunami in Japan and during the summer, the drought in the Horn of Africa. Working with local and global relief partners, PWRDF has an edge on getting emergency relief into difficult areas, including Somalia.

So many parishioners have contributed to PWRDF and our events over the last year. Congratulations to Allison Brooks and the Sunday School for raising \$1,182 for bicycle ambulances. Thank you to Ken Miller for donating half the proceeds from the Heaven Cent Fund to PWRDF, to Alison Stortz and Carol Spencer for printing my articles. Particular thanks to Father Craig for his support.

Anglicans often associate PWRDF for their relief work but we should not forget the 'D" for development which needs ongoing funding. This year it has been my goal to emphasize PWRDF's role in sustainable development. It is in the rebuilding and development work for vulnerable communities throughout the 12 FEB 2012

world that PWRDF is shining. In past years PWRDF has been recognized by the UN for its work after the 2004 Tsunami. PWRDF projects are meeting the tight CIDA criteria. PWRDF partners are being recognized for the work that they are doing to improve the lives of people in their communities; e.g. The Keiskamma Trust in South Africa; in Sri Lanka, T.M.J. Sarath Fernando of MONLAR (Movement for National Land and Agricultural Reform) and in Mexico, CEDEHM (Centre for Women's Human Rights).

PWRDF staff have been visiting our partners overseas and are seeing very positive results; including expertise in sustainable ecological agriculture; access to water; improving healthcare; building schools and houses; supporting: AIDS orphans, prostitutes and their children in Asia and Africa, refugees around the world; establishing micro credit, working towards social justice; working with the youth of our First Nations communities and other indigenous communities, and none the least feeding, the hungry and providing shelter.

To support PWRDF's ongoing development projects, St Paul's held our fall dinner "Around Africa with PWRDF". Many parishioners contributed to the success of the event. Attended by over 100, the evening highlighted what the initials PWRDF represent and showed the holistic approach PWRDF has to relief and development. Our special guest was the Rev. Carolyn Langford who for 20 minutes transported us to Africa as she spoke about her experiences in Uganda. We also welcomed Valerie Maier our PWRDF Diocesan Rep and Jane Maxwell a former PWRDF staff member.

From the dinner, St Paul's was able to send a cheque to PWRDF for \$1,658. I recently received a letter from Jill Martin, Finance and Administration Manager PWRDF, I quote: *"Please convey our sincere thanks and appreciation to all those who attended and contributed to the evening."* She also thanked *"The friends of PWRDF who have consistently supported its ministry through parish events since its earliest days."* I know that we have some parishioners who have been supporting PWRDF for many years.

PWRDF is truly "... a response by Canadian Anglicans to the gospel call to bear witness to God's healing love in a broken world..." The community of St Paul's is hearing that call.

Our curriculum is designed to create monthly opportunities to connect with other youth groups, learn about our faith, create a community of youth within St. Paul's and reach out with ministry to this community and beyond.

Our goals for 2012 are to strengthen relationship between the young Christian peers in our midst and to create an environment where youth who are churched and unchurched alike can comfortably receive an introduction to the blessing of Church.

The ministry is driven by a team of seven REMARKABLE leaders who over the past year have generously shared over 1408 hours of their time. ### **BUILDINGS & SITE**

### **Building and Site**

Our building is maintained by a group of individuals who come together at various times or through signup sheets to make God's presence known in the world. Our church is like a hub on the wheel with the parishioners being the spokes. The hub needs continual maintenance to keep it turning smoothly. There is outside maintenance such as repairing the shingles on the roof after the bad wind storm, pruning the trees and hedges, cutting the grass, sweeping the parking lot, shoveling the snow, throwing down salt, repairing cement work and washing the windows. The inside work is a long list as well; repairing pews and kneelers, patching and painting the walls, repairing toilets, replacing faucets, unclogging drains and adjusting heating controls to name a few.

Speaking of the heating controls the church has always had two thermostats to operate the furnace. One thermostat controls the temperature of the nave during unoccupied times and the second thermostat controls the temperature when the nave is occupied. How do we know when each of these times begin? I have upgraded the timer control unit for the nave furnace to change from one thermostat to the other depending on the hour or day. As an example if there will be a reoccurring activity happening in the nave every Tuesday beginning at 6:00 and ending at 10:00, I will set the timer control unit to use the occupied thermostat at 5:00 so the nave is at the preset temperature for 6:00 and then set the timer control unit to 12 FEB 2012 24 use the unoccupied thermostat at 10:00 so the nave furnace is not wasting natural gas or money keeping the temperature up over the night time. As you can see adjusting the unoccupied thermostat to a higher temperature during the time period between 5:00 and 10:00 does nothing for that time; if not turned down this thermostat will keep the temperature at that high level overnight as that is when the unoccupied thermostat is used.

Of course the never ending job of replacing burnt lights and ballasts. LED lighting is becoming popular; however, LED lights are still expensive and too directional for general lighting. I have installed two LED lights in fixtures to test their longevity compared to the CFL bulbs. These two lights are left on 24 hours a day as security lights. It may take three years to determine a winner; I'll let you know by Vestry 2015.

There have been some modifications inside the Nave. The outcrop in front of the pulpit was removed. The first step or landing now has a wider path for the clergy or lay assistants to pass by when offering communion. At the front of the Chancel, a portable modesty screen is now used.

The three sink washing area in the kitchen has a new extendable flexible set of taps. Spraying or filling each sink is easy with a push of button.

Outside, the big change is to the memorial garden. A stone walkway with a circular sitting area has been laid. I am sure flowers, shrubs and benches will be seen sometime soon.

Did you miss seeing our new elevator or lift? This addition makes access to and from both levels easier. A key is required to unlock and open the door; this key is available from the Welcome desk. You can be whisked down to the lower level in a matter of two minutes. Don't be shy give the lift a try.

With profession help the hard surface was laid, a 'patio' and pathways. The earth was covered with landscaping cloth to reduce weed growth, and stakes are in place marking the sites of some of the trees. The arbor and seating will return when the planting is completed. We hope this will be a quiet but inviting area for anyone wishing to use it.

### Tech Team

For most of the year the Tech Team had a pretty quiet year. Our systems worked well. Normal routine system maintenance tasks were completed as needed. Over the Christmas break we undertook a major upgrade on our firewall, moving from IPCop V1.4.18 to IPCop V2.0.2. This upgrade gives us greater flexibility in managing our internet services.

It should be noted that some of our machines are getting old, and we will need to plan for replacements in the next year or so.

In September, a new web sit was unveiled. The new site is powered by a Joomla Content Management System, making it easier to add, update, or remove content. We continue to use the hosting services of 12 FEB 2012

<u>www.emoss.ca</u> for security and service level considerations. The content of the site is provided by the Communications team.

In December we undertook a complete replacement of the sound system in the church. The immediate benefit of the new sound system (which includes a digital sound board coupled with new amplifiers and speakers), is a noticeable improvement in the quality of both spoken word and music within the church. In addition, the new system allowed us to simplify our equipment and remove multiple audio components and speakers, and achieve a better sound with less equipment being in place and visible. As the new system is digital, it allows us to fully store/recall the settings and preferences across all services, so that we have much better consistency on a weekly basis, as well as integration to computer and tablet devices so that we can adjust the settings from anywhere in the room. The new system also provides better integration to the computer for other A/V capabilities, such as slides, recording, and CD/DVD playback, so that we have the capability to introduce new technical capabilities down the road. I would like to thank Wall Sound, and their systems technician Mark Warren, for their expert assistance in the installation and setup of the new system.

I would like to thank Michael Turnbull, Rob Andrews, Geoffrey Colls, and Colin Mackenzie for their gifts of time and talent in support of this ministry.

### COMMUNICATIONS

### **Communications Update**

In 2011, we outlined a new mission for the St. Paul's Communications team, to "develop, implement, and coordinate a best-in-class communications program for St. Paul's that raises awareness, informs, and educates across our growing community, and provides a leadership example within the Diocese", as well as four strategic areas of focus: process definition and documentation, branding/coordination, information collection, and the need to expand/explore new communications methods.

Significant progress has been made during the year across all four strategic areas. Draft processes have been developed around common communications areas (how information gets communicated, to whom, who approves, and which method is appropriate for which audience), and they will continue to be refined, documented, and published, so that we have a consolidated view of communication processes, helping to streamline existing processes and communicate more effectively.

A lot of visible progress has been made on our branding initiative, which was a key area of focus in 2011. Branding is an important element of our communications, as it helps to improve our credibility and professionalism, helps us look more together, organized, and polished, and it gives us a consistent visual identity that stands out, so when people see something from us, they know that it comes from St. Paul's. It also helps us in the background, by giving us a more efficient workflow and process, including highquality templates that were created for the major communications areas. We now have branding guidelines in place, involving a cleaner and more polished look/feel, an emphasis on the St. Paul's logo, and a shift towards cleaner layouts and photo imagery. We have updated business cards, a new look and organization to our web site (which also brings us some advanced technical capabilities), and updates to our bulletins, Cornerstone, and posters.

We have also reviewed our information collection: including looking at both best practices and Diocese privacy guidelines, and have begun using online registration and database collection for parish events,

now that our website back-end technical capabilities are extended to include secure database features and more complex scripting.

We also expanded our use of communication methods and explored new options: this involved leveraging appropriate technology options to cater to the technology-savvy Kanata community, while still ensuring a balance of traditional methods. We have not only extended our website to use online event registration and database capture, but we have also branched out into social networking, with Facebook and Twitter pages, as a way of extending our community into the online world.

What's coming in 2012? We're planning to further expand our online community in areas such as regular blogs; and given the new audio/visual capabilities at St. Paul's, we'll have opportunities to further leverage Internet communications as a part of our regular services and special events. The work completed in 2011 by the entire St. Paul's Communications team provides a great foundation to build on, and ties us back to our mission of ensuring a best-in-class communications program that raises awareness, informs, and educates across our growing community - we're looking forward to continuing that progress in 2012.

### FINANCE

### **Envelope Secretaries**

There were 292 identifiable givers in 2011 (299 in 2010) who gave an average annual giving in 2011 of \$1,084 (\$1,002 in 2010). Identifiable givers are parishioners giving \$25 or more in the year.

At year-end 2011 there were 111 parishioners using the Pre-Authorized Withdrawal (P.A.W.) program. Offering envelope boxes for 2012 were issued to 152 parishioners.

Envelopes continue to be available to those parishioners who wish them. We have encouraged the use of the P.A.W. program in several ways throughout the year. The P.A.W. program is a convenience to both the parishioner (no envelope to remember on Sunday or makeup after vacation) and to St. Paul's (a consistent, identifiable cash flow). Applications for the P.A.W. program, as well as a "Revision Form" for current P.A.W. participants, are available on a table in the Narthex (front foyer) of the Church or from the Church Office. A signed Application (with a voided cheque) or a signed Revision Form is required to start or make a change to your donation amount.

There continues to be a few parishioners who contribute regularly via pew or personal envelopes. We encourage anyone interested to request a box of Offering Envelopes or to sign up for the P.A.W. program as it makes the counting and recording of donations easier for us and the counters.

A letter from St. Paul's to visitors is mailed out by the Thursday following the Sunday their donation is received thanking them for their donation and if they are looking for a church home, inviting them to become part of our community. We sent out 16 such letters in 2011.

We would like to thank the counters for their valuable assistance over the past year. Their help is much appreciated by us and by St. Paul's.

### Gift Certificate Program

For 2011 Parish Council budgeted for \$12,000 and we earned \$10,960. Approximately \$910 was used by the church for expenses, e.g. Feast of Christ the King. The extra is retained in the program to help with the cash flow. Currently we use a line of credit which last year cost a net of \$283.82. Our aim is to get off the line of credit completely.

### Treasurer's Report

The most important thing when it comes to finances is that they be consistent. Not wanting to break that cardinal rule, most will find that the treasurer's report is consistent year over year.

The 2011 financial year was almost predictable. There were times where your fiscally conservative treasurer did not think that we would make our commitments. With a great deal of prayer and the help of all that answered the appeal from your wardens we achieved a positive position at the end of December.

Our receiptable income (envelopes, capital campaign) was 99% of budget. Envelope offerings had an impressive 8% year over year growth. Our other income category also came very close to the budgeted number. Both of these numbers are significant achievements as the 2011 revenue numbers were certainly stretch goals in a difficult economic climate.

I wish to thank the numerous organizations who made significant financial gifts to the church. The Bazaar, Quilting group, Chicken Bar-B-Q, Gift Certificate program, Coffee Program and the choir have contributed to the finances of St. Paul's. Our rental coordinator, Lorna Brûlè, also deserves a vote of thanks for managing the rentals this past year. Our bottom line is significantly affected by the faithful work of these groups and individuals.

### Cash Flow:

The three items that most people will question the above snap-shot:

## **Building**: If you excluded the sound system upgrade of \$ 10,490 from the reported figure, the building figure would be reported under budget

**Bank Charges**: The amount reported included the cost of the debit machine for the gift card program and bazaar.

**Miscellaneous**: Higher than anticipated HST expenses from the capital projects completed (Elevator), and Professional Fees for the same.

The expense most affected by increased spending in 2011 is under the building category. This expenditure was not unexpected as we continue to improve our Worship space. The installation of the sound system and of the lift both affected this budget line item. As our building ages this line item will be of greater importance as we continue to support our awesome facility.

With the increased pressures we are going to face in 2012 our collective annual giving will need to be reevaluated.

One of the vehicles to help with forecasting is to achieve greater participation in the Pre Authorized Withdrawal, or PAW program. Currently 52% of our envelope income is realized through the PAW program.

For St Paul's community to have the greatest impact, we must continue to make spending decisions with a clear view of the modified mission of St. Paul's. With our focus now on worship, teaching and equipping we must be purposeful in our relationship with the St. Paul's and accepts the commitments to make our mission a reality.

There is no doubt that we have much to be proud of. My personal preference is to report a surplus instead of a deficit. It is much easier to explain.

We have over the last 7 years been blessed with a financial position that many parishes do not share. With this track record come certain expectations. We must all remain committed to the challenges that are put in front of us. We can do all things through Christ who gives us strength.

#### AUDITOR'S REPORT

Parish Council St Paul's Anglican Church Hazeldean-Kanata

We have audited the financial statements and records for St Paul's Anglican Church Hazeldean-Kanata as at 31 December 2011. These financial statements are the responsibility of the Parish Council. Our responsibility is to express an opinion of these financial statements based on our audit.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used, as well as evaluating the overall financial statement presented.

Retention of Parish Financial Files and a policy that covers Parish Signing Officials were discussed.

It is our recommendation that the Corporation and the Parish Council approve a six year period for the retention of St. Paul's financial files and records.

With regard to the issue of signing officials for the accounts that are held within the parish, we recommend that the Corporation make known to the Council each year, the names of the approved signing officialss and the protocol for each account.

In our opinion, the financial statements, to be presented to Vestry, present fairly, in all material respects, the financial position of St Paul's Anglican Church, Hazeldean-Kanata as at 31 December 2011 and the results of the Church's operations.
