We now hand the reigns to Danielle & Colin Mackenzie and Tom Baker. It has indeed been a privilege to serve such a wonderful community as St. Paul's.

The last year has been one of great times and busyness. Fr. John and Fr. Craig have been kept quite busy (in a good way). Fr. John and Fr. Craig have been asked to provide a service the last Wednesday of the month at Garden Terrance. Our honorary assistant Fr. Bill has gone to the Parish of Kars-Osgoode to assist them until a new incumbent has been found. We welcome Fr. Charles Boole as Honorary Assistant.

We held a number of Town Hall meetings that helped to plan out a direction for us to see where we need to go as a Church of the future and where we should be looking at providing a better or new ministry within St. Paul's' and the wider community locally and beyond.

From the draft that we have seen of the present document, this will be an awesome book. If you didn't have your photos taken last year, by Prestige Images, you can look forward to April when they will be back. Thank you Lynn Williams for coordinating this huge task!

On another note we bid a big thank you and farewell to Lynn Williams and Zdena Harder as they are stepping down from Parish Council, you have been a great Blessing to St. Paul's.

A thank you to Michael Turnbull and his group for looking into the best solution for the repair for the roof and getting quotes for the work that needed to be done.

St. Paul's has been approached by TELUS to allow them to install a cell tower on the Church. Colin Mackenzie is looking into the logistics and the benefits to St. Paul's. This is still in the investigation stage.

#### **Growing In Faith Together (GIFT) Campaign**

Glory to God, whose power working in us can do Infinitely more than we can ask or imagine...

St Paul's GIFT program is now well into its second year. Our results have been exceptional thanks to the generosity and faithfulness of our parishioners.

As of December 31st 2013, our GIFT pledges and donations now total \$494K. This is 123.5% above our original goal of \$400K. It is also an increase of \$29.2K from our 2012 year-end position.

Our partner in this GIFT Campaign, the Diocese of Ottawa, reports that they too have met and surpassed their target of \$12M by \$337K thanks in part to the success here at St Paul's. Many examples of what ministry GIFT has allowed the Diocese and Parishes to accomplish may be found in the monthly issues of CrossTalk, the Diocesan newspaper.

In terms of actual and intended disposition of St Paul's GIFT Campaign funds (see thermometer attached), we have now paid down St Paul's mortgage by close to \$200K, 2/3 of the way to our \$300K target. By the end of 2014, we will have paid down a further \$100K with GIFT funds leaving our mortgage owing at approximately \$595K. This will then allow for us to begin dispersing funds to the other priorities identified in our GIFT Campaign *Case for Support* as follows:

- The next \$100K received beyond \$300K will be shared 50/50 with the Diocese of Ottawa. As agreed at our Special Vestry last September, the \$50K attributed to St Paul's will be used to pay for the new clerestory roof which has just been completed.
- As per our agreement with the Diocese, the next \$50K (beyond \$400K) will be entirely earmarked for St Paul's ministry and facility enhancements as per our *Case for Support*, namely:
  - Seniors' ministry programming
  - Youth ministry programming
  - Air conditioning for Rutter Hall
- The final \$44K (beyond \$450K) has not as yet been designated. Corporation and Parish Council will work towards establishing priorities for these funds and will engage Vestry in due course with recommendations for Vestry approval.

We are blessed at St Paul's to have such a wonderful community of committed parishioners who so willingly and sacrificially give of their time and their resources to further our delivery of ministry both within and beyond our church walls. Our GIFT Campaign success provides significant flexibility to address unforeseen priorities (witness the clerestory roof project) as well as opportunity for fulfillment of existing and future ministry.

The GIFT Campaign will be ongoing for a further four years as pledges and donations are received. There remains an opportunity for those who are new to our parish, for those who have not yet had a chance to contribute, and for those who may be in a position to augment their initial contributions to participate in St Paul's GIFT journey. Our mission and ministry will continue to depend on the generosity and faithfulness of all our parishioners. And, there is certainly no shortage of opportunity to which GIFT campaign funds can be applied. We have GIFT Campaign brochures available (just ask one of the undersigned co-chairs or the church office) which provide additional detail concerning GIFT and what we hope to accomplish with the funds raised.

The GIFT Campaign is a large and complex undertaking requiring significant diligence to maintain proper accounting and administration. As GIFT co-chairs, we would like to express our gratitude to our treasurer, Mark Stalter, our envelope secretaries, Bob & Nancy Moxley and their counting team, and especially to Wayne Keech, our GIFT Campaign administrator for helping to keep track of every GIFT pledge and donation.

We all should be very proud of what we have accomplished in this parish, and very thankful that God continues to bless us with the desire and ability to respond to His Call in such a meaningful way.

Praise God from whom all blessings flow....

#### Summary of Synod 2013 - Vestry Report

The 132<sup>nd</sup> Session of the Synod of the Diocese of Ottawa was held October 18th and 19th, with the theme "Whatever You Did to the Least of These...You Did to Me".

Attending for St. Paul's were: Father John and Father Craig, Heather Colls, Linda Keech, Colin Mackenzie, Lauren McCabe and Vera Near.

The keynote speaker was the Bishop of the Episcopal Diocese of Jerusalem, the Rt. Rev. Suheil Dawani, who gave us an overview of the Diocese of Jerusalem and its challenges and triumphs. There are three cornerstones to Bishop Dawani's ministry: Pastoral, Institutions, and Interfaith.

The Diocese of Jerusalem is spread over five countries: Syria, Lebanon, Jordan, Palestine and Israel, covering 9000 Anglicans in 29 Parishes, and administering various institutions including 2 hospitals, 7 medical clinics and 20 schools - a challenge given the stability of the area, and where less than 5% of the population is Christian. All are welcomed in those institutions no matter their religious affiliation.

The Diocese of Jerusalem has partnered with other Dioceses, including the Diocese of Ottawa. To help support the Diocese of Jerusalem's ministry, the Diocese of Ottawa presented \$20,000.00 to Bishop Dawani, \$5,000.00 from the Diocese and \$15,000.00 from PWRDF (which had been contributed by the Diocese of Ottawa). The funds are to be directed towards the Gaza hospital.

Bishop Dawani's wife, Mrs. Shafeeqa Dawani is also active with women's ministry, and together with Bishop John Chapman's wife, Mrs. Catherine Chapman, they are planning a women's conference in the Holy Land in 2015.

The session also heard many presentations on the various ministries and outreach programs that are on-going in the Diocese, many of which are already benefiting from GIFT proceeds.

Some of the ministry highlights are:

- St. Luke's Table has now become a funded Diocesan ministry at St. Luke's Church in downtown Ottawa
- Director of Mission position established in Diocesan office
- PWRDF Diocese of Ottawa is one of the largest contributors. In 2012, we gave over \$300,000.00 to PWRDF
- A motion was passed that changed the assessment formula for the Equalized Cost of Priestly Services (ECOPS). This resulted in a more favourable situation for St. Paul's.
- Diocesan receipted donations in 2012 totalled \$10.6 million, with average weekly givings of \$23.25

In summary, Synod was extremely informative and we can rejoice that we are part of such a vibrant and worshipping community that is committed to ministry and outreach at all levels.

Many thanks must go to Minx Mulhall our treasurer and all those who made things for sale and to those who stood behind the tables and served the public. Also many thanks go to those who helped us to set up and those few who stayed behind at the end to clean up. It was a great time for all.

I hope many of you are starting their crafts and knitting for next year. Is there someone who is good at crafts and would start up a crafts time to help for next year for the Christmas Bazaar?

We must remember all goes back to our church and in that we are the winners. Thank you for sharing your talents, time and money.

#### Chicken BBQ, 2013 – Mathias Joost

Once again our Lord has blessed us with weather in which we could cook the chicken and with a marvelous group of volunteers who made this event a success. St. Paul's annual chicken BBQ was held on 7 June under slightly misty skies. This year 509 ½ chickens were sold, while our carbon footprint was greatly reduced. Just over \$3,800 was raised including donations of over \$240. One reason for the increased revenues was the great price received from Farm Boy for their birds, which were again plump delicious examples of fowl.

We were blessed with a great turnout for all aspects of the BBQ. Our volunteers did a wonderful job in all aspects starting with the John Milburn selling oodles of tickets, Valerie and Edna helping with making the cole slaw, to "the guys" setting up the BBQ. The quilters and friends did their usual outstanding job cutting pies and preparing the buns and butter. A wonderful smoke screen created by Michael Turnbull and his gang of assistants and supervisors kept the mosquitoes away. It took them a little longer this year because of the mist, while extra bags of charcoal were required, but they persevered and cooked the chicken to perfection.

Our serving team was up to the challenge, kept busy handing out the birds and dealing with a new twist this year. For those eating in, they received their chicken on the church's dinner plates while the take-out chickens were served in compostable containers. With all those plates and the cutlery the kitchen staff was kept busy but handled the cleaning duties magnificently. In fact, by the time the serving line closed at 7:00, Rutter Hall was so clean that the clean-up crew was done by 7:15.

Our final thanks must go to the volunteers who provided pies and all of you who bought chickens.

#### Coffee Hosts - April Boomer

Thank you so much to all the fabulous coffee service volunteers for generously giving their time to serve the coffee, tea, and juice as well as preparing the wonderful snacks for all to enjoy. The 8:00am parishioners still maintain their own schedule. The coffee, tea, and juice are supplied by the church and the milk and cream are provided by those on coffee duties that shift. One thing that has left me in AWE since taking over the Coffee Host Program last Spring is just how giving the St. Paul's community is. What an amazing time the after service coffee is; full of wonderful people and our family feels blessed to be a part of St. Paul's congregation.

#### Senior Afternoon Out Program - Minx Mulhall

Many of the seniors come from area retirement & nursing homes. As well we provide transportation to people who live on their own.

Our time is spent together in sharing a time of Christian worship & fellowship with one another.

We are so often blessed to have area musicians, singers & groups who give of their time to entertain us after our worship time in the church. The program starts at 2:00 p.m. and we finish up at 3:15 p.m. in time for the buses & drivers to pick up.

It is a wonderfully blessed time for the seniors and volunteers alike. Some of the volunteers come weekly, some come once a month. #### **PWRDF** Submitted by Philippa Wilson

2013 began with the news of the surge of Syrians fleeing to neighbouring countries to escape the devastating violence that was occurring around their homes due to the ongoing civil war.

Fundraising doesn't have to be serious, thank you to the whisky tasters at the *Burns Supper* for during your moments of high spirits remembering and donating to the work of PWRDF.

For Lent, The Diocese of Ottawa PWRDF Committee "challenged every parish in our diocese to hold an educational/fundraising event, Feb. 17-24, to raise awareness of poverty issues, while supporting PWRDF development projects in Canada and the world".

St. Paul's response to the Poverty Challenge was to recognise the plight of the Syrian refugees and in particular the children. On February 17<sup>th</sup>, our Sunday School children brought baskets to the Congregation and held a Loonie/Twoonie drive (to some of our parishioners that includes \$20 bills). The Sunday school children raised over \$400. Our Youth group was asked how they would want to respond to the *Poverty Challenge*. They chose to make and sell bracelets. Many of us remember the figure of 10 year old Chloe Bowers making an announcement on Sunday morning, explaining why we should not forget the Syrian children. Chloe and the Youth Group raised over \$500. Throughout Lent, donations to the Monk's Lunches and our Lenten Study were also collected for the Syrian refugees. Not forgetting those in need in Canada, as part of the *Poverty Challenge*, we also held a food drive on February 24<sup>th</sup> and filled 3 shopping baskets of food for the Kanata Food Cupboard.

Saturday, April 20th, St. Paul's hosted the PWRDF Diocesan workshop. Many of our parishioners also attended the event. Our first guest speaker was Zaida Bastos, PWRDF's Program Coordinator for CIDA (now FATDA) projects, formerly PWRDF Africa Program Coordinator. Prior to joining PWRDF she had worked with refugees, UNESCO in Paris and for United Nations Development Program in Angola. Zaida talked a little bit about the pros and cons of the government changes to CIDA and its merge with Foreign Affairs. Mostly she focused on PWRDF programs in Africa and Asia that are supported by grants from the Canadian Government; her personal observations, practical considerations and successes e.g. 40% reduction in in maternal mortality in Burundi in just one year.

Our second speaker was Mackie Robertson, a farmer from eastern Ontario who has been volunteering for PWRDF's partner, The Canadian Foodgrains Bank for over 18 years. Mackie has been on three monitoring or awareness trips to India and Africa to see firsthand the impact of the Canadian Foodgrains' gift of food aid to areas devastated by war or natural disaster. Don Smith our Diocesan Refugee Coordinator spoke briefly about the changing Canadian attitude to refugees. Our Diocesan committee spoke about the challenge of bridging the gap between ourselves and our aboriginal communities; how do we communicate the suffering that has occurred and how do we move forward. Our unexpected but special speaker was Chloe Bowers who made a presentation to Zaida. Chloe inspired many of us to continue our work towards a "truly just, healthy and peaceful world" and was featured on the PWRDF national website and in PWRDF's Advent study guide.

We had our shares of disasters this year including Syria, the Alberta Flooding, Lac Megantic and the devastating typhoon Haiyan in the Philippines. The generosity of this parish is overwhelming and I try to keep you informed through the bulletin and Cornerstone that your money is much appreciated and is being well used; to quote Geraldine Labradores from one of our Filipino partner agencies: "it is a sad fact that the poor and marginalized are the most affected in times of disaster. Your help will not only help them make it through this difficult time but also help them rebuild their shattered communities". We ended the year with our Christmas card sales raising another \$360.

As your PWRDF representative, I am also on the diocesan PWRDF committee, which has been very active this year. On May 3<sup>rd</sup> we hosted a Congregational workshop on *Indigenous People's Activism* featuring Viola Thomas of the Truth and Reconciliation Commission and Gabrielle Fayant of the Idle No More Movement; we supported our Toronto staff at the Joint Assembly; coordinated with Toronto for our Director Adele Finney (last minute substitution, Carolyn Vanderlyp) to present a plenary session at the Ottawa Synod; coordinated with the diocese for the presenting of a

GIFT cheque for the Al Ahal Arab Hospital in Gaza (part of PWRDF's Connections Program); supported and received diocesan funding and representation at the ecumenical Covenant Chain Link Workshop "Building Bridges of understanding between Aboriginal and non-Aboriginal peoples through respectful relationships as we learn from our past to shape a new future".

I would like to thank St Paul's for this opportunity to be your parish representative, as though the year has presented many challenges, including giving our Indigenous Bishop, Mark MacDonald a ride to the airport in a very crowded Mazda 3 (just as well he is a laid back person), I have met many inspirational people; young people such as Chloe Bowers and Gabrielle Fayant, older people such as Viola Thomas, Adele Finney (Director PWRDF), Very Reverend Mark MacDonald and even our Primate the Very Reverend Fred Hiltz to name just a few. Most importantly at this time I would like to thank the congregation of St Paul's who always step up to the plate with your time and generosity and continue to inspire me. All are important on the journey to "A truly just healthy and peaceful world" and all give glimpses of what the Kingdom of God can be.

<u>Kanata Food Cupboard</u> is a registered charity and run out of our basement here at St. Paul's by an elected board of directors. The Kanata Food Cupboard serves the community and that is the boundaries of the old City of Kanata, we provide food to those who need it.

The St. Paul's team is one of six groups made up from local churches in Kanata. We work weekly, working on a rotation of every six weeks. This past year we have seen many changes and now we are settling in to a complete new way of operation. On Monday, Wednesday and Thursday the clients come and shop with our guidance. On Tuesday and Friday we still pack and deliver food to families who for some reason can not get to the Kanata Food Cupboard.

Our volunteer team is almost 50 people, that is wonderful. Not everyone is available every time we are on so having more volunteers is a good idea. We are always in need of more people to help the clients shop and pack and delivery couples. If you are interested please see me or give me a call 613-509-1304.

Thank you to all the volunteers who faithfully say yes when I call/e-mail and to all of you who donate in cash and food. This makes our church here stronger.

This is an outreach here at St.Paul's and this makes us very visible here in the community and beyond. We are here to serve those who need food.

#### **Building and Site Maintenance - Steven Shamess**

What is the number one maintenance item for the church? What is the costliest maintenance item for the church? How high have you been in the church? How many furnaces heat our church, offices, classrooms and hall? As our latest iteration of St. Paul's nears its 10th year there are repairs we must do to our St. Paul's home just like in your personal home. Over this past year we had major repairs to our furnaces; Motors have died, circuit boards fry, dampers get stuck and flues leak. Remember Genesis 1:3 And God said, Let there be light: and there was light.

What was not told is we would have to keep changing those light bulbs. This is the main maintenance item; I change over 20 bulbs a year. I change bulbs where you did not know there was a bulb - one can walk in the attic above the washrooms and kitchen and there is a bulb to light the way. I have reached for the sky - literally - I had to reach out from the Genie lift I had set on the altar steps to change one spot light on the cross member in the clear story. Now that is high!

I have been performing long term testing of LED lighting. So far the longevity has been good; however, the initial cost of one bulb is far more expensive than using two or three CFL bulbs. The return on investment for the LED bulbs begins 2 years after its life has ended. Clearly, changing to LED lighting is more for a matter of convenience. We shall see how the LED spotlight fairs against the Halogen lights shining on the Altar.

Lastly, three things should be completed this year. The shingled roof atop the church is being replaced with a metal roof; those shingles did not want to stay on that steep angled roof. So this metal roof will be that last one we will need. Secondly, the bridge walkway for the kitchen entrance is being rebuilt. Lastly, the external sign for St. Paul's will be completed.

So what is the costliest maintenance item? Could it be the 5 furnaces and 2 air conditioning units? Maybe it is clearing the parking lot of snow every year or would you consider a new roof to be the costliest? It really depends on how you look at it; the roof is a onetime charge which will require no maintenance for at least 50 years. The HVAC do have yearly maintenance costs; most of this is unexpected and it seems to be related to power. The snow falls and is only removed either by a plow or springtime. Since we cannot wait for spring to melt all the snow away we pay and pay and pay.

Looking forward I see work needs to be done on the floor tiles at the entrance doors. Several outside doors have been sanded and painted last summer - thanks to Mathias for that effort. The outside hand rails will have to be sanded and painted this spring. Some asphalt work and maybe line painting can be attended to this spring. As always there will be plenty of work to do.

The completion of the Memorial Garden has diminished some of our major work. The addition of more mulch to more areas has decreased the need of weeding and helps with keeping the ground moist, as well as giving the gardens an improved appearance.

We hope to have a Memorial sun dial installed in the Memorial Garden. The dead tree by the north entrance needs to be removed and replaced (?) The apple trees on the south side had abundant fruit this year; the members of the congregation were encouraged to pick them. Some apple jelly was made from the apples and sold at the Bazaar! The help of new team members to the gardening ministry was welcome and appreciated.

Any one wishing to join the team to help keep the grounds looking good is welcome!

#### **Tech Team** - William Colls

We had a generally quiet year, with our equipment running smoothly in support of the many activities at the church.

During the summer we added a compact video camera in the church, which allows us to make all services available on the internet. As currently configured, it allows a theoretical maximum of 5 simultaneous connects, although experience suggests that the practical limit is probably 3. If there is sufficient demand, we will investigate an alterative set up that would allow a larger number of simultaneous viewers. In order to support the increased data volume of streaming video, we changed our internet provider to Bell (from Rogers), and after a couple small hiccups, and some fiddling around, that is now is working very nicely.

I take this opportunity to thank Rob Andrews, Colin Mackenzie, Michael Turnbull, and Steve Shamess for their dedication and on-going support in this ministry.

#### **Envelope Secretaries and PAW Coordinators** - Bob & Nancy Moxley

There were 324 identifiable givers in 2013 (328 in 2012) who gave an average annual giving in 2013 of \$1,100 (\$1,021 in 2012). Identifiable givers are parishioners giving \$25 or more in the year to the General Fund.

At year-end 2013 there were 121 parishioners using the Pre-Authorized Withdrawal (P.A.W.) program. There were 114 at the end of 2012. Offering envelope boxes for 2014 were issued to 175 parishioners, up from 159 boxes issued at the beginning of 2013.

Envelopes continue to be available to those parishioners who wish them. We have encouraged the use of the P.A.W. program in several ways throughout the year. The P.A.W. program is a convenience to both the parishioner (no envelope to remember on Sunday or makeup after vacation) and to St. Paul's (a consistent, identifiable cash flow). Applications for the P.A.W. program, as well as a "Revision Form" for current P.A.W. participants, are available on a table in the Narthex (front foyer) of the Church or from the Church Office. A signed Application (with a voided cheque) or a signed Revision Form is required to start or make a change to your donation amount.

We would like to thank the counters for their valuable assistance over the past year. Their help is much appreciated by us and by St. Paul's.

The most important thing when it comes to finances is that they be consistent. Not wanting to break that cardinal rule, most will find that the treasurer's report is consistent year over year.

The 2013 financial year was almost predictable. This past year was different from others. There was a sense that finances were under control instead of behind the curve. While we did not meet budget targets we as a parish kept expenses under control and we did see a growth in receiptable income.

Our receiptable income (envelopes, capital campaign was 99% of budget. Envelope offerings had 6% year over year growth. Our other income category trailed this year due to several factors. There was the loss of anticipated revenue from renters and a decline from group efforts. It is important to note these numbers are significant achievements as the 2013 revenue numbers were certainly stretch goals in a difficult economic climate.

I wish to thank the numerous organizations who made significant financial gifts to the church. The Bazaar, Quilting group, Chicken Bar-B-Q, and the Gift Certificate program have all contributed to the finances of St. Paul's. Our rental coordinator, Lorna Brule, also deserves a vote of thanks for managing the rentals this past year. Our bottom line is significantly affected by the faithful work of these groups and individuals.

#### Cash Flow:

There is really only one item that people might question with the above snap-shot:

Bank Charges: The amount reported included the cost of the debit machine for the gift card program and gift campaign credit card run.

The expense most affected by increased spending in 2013 is under the building category. This expenditure was not unexpected as we continue to improve our Worship space. The installation of the sound system and of the lift both affected this budget line item. As our building ages this line item will be of greater importance as we continue to support our awesome facility.

With the anniversary celebration in 2014 there will be pressures on our budget and associated givings in 2014. I remain confident that we will rise to those pressures and keep them in perspective.

One of the vehicles to help with forecasting is to achieve greater participation in the Pre Authorized Withdrawal, or PAW program. Currently 52% of our envelope income is realized through the PAW program.

For St. Paul's community to have the greatest impact, we must continue to make spending decisions with a clear view of the modified mission of St. Paul's. With our focus now on worship, teaching and equipping we must be purposeful in our relationships and accept the commitment to make our mission a reality.

There is no doubt that we have much to be proud of. My preference is to always be able to report a surplus instead of a deficit. It is much easier to explain.

We have over the last 10 years been blessed with a financial position that many parishes do not share. With this track record come certain expectations. We must all remain committed to the challenges that are put in front of us. We can do all things through Christ who gives us strength.
