Warden's Report

With Vestry approaching quickly, we have come to the end of our term as Wardens, and now have a wonderful opportunity to look back and reflect on the past year - a year which has been full of change and a lot of hard work, but has always been a blessing and a privilege to serve the community of St. Paul's.

One major change for St. Paul's in the past year has been the team ministry model we have adopted with Christ Church Ashton. While change and adjustment is always a challenge, especially with a model such as this which is new in our Diocese, it has not only allowed us to get involved and bless Christ Church Ashton in terms of clergy support and ministry (especially with Fr. Craig who was involved more directly in the initial stages of implementing this team approach), but it has also allowed Christ Church Ashton to bless us back. We are richer as a community when we can come together in faith and develop new ideas together as a church. These changes have also allowed St. Paul's to introduce a more decentralized team approach with our own congregation, allowing for more active involvement from our Honorary Assistants.

St. Paul's also introduced changes to the Parish Council model over the past year, resulting in the formation of a number of new teams focused on support of the ministries, as well as planning for the future. These changes have helped to streamline the reporting and decision-making of the various ministries within St. Paul's, and have resulted in better use of time for our precious volunteer resources.

We celebrated together often throughout the year, both as a congregation within St. Paul's, as well as with the broader community. St. Paul's held a number of successful events, such as the Robbie Burns Dinner, a Caleigh evening, our annual Chicken BBQ, a fundraiser and silent auction for the Ruddy-Shenkman Hospice, and our annual Christmas Bazaar. As always, St. Paul's provided many wonderful opportunities where we could celebrate together as a community, both to socialize as well as to come together in faith. A number of projects were also completed throughout the year, including improved audio/visual capabilities resulting from a new integrated sound system, computer, and tablet, allowing for better quality of sound and video during services and special events, as well as more flexibility to control the system easily from anywhere in the room.

We would like to thank all of St. Paul's for the opportunity to serve the congregation as Wardens, and we wish the best of luck to Elizabeth Vincent and Minx Mulhall, as well as to the new incoming deputy Wardens.

Parish Council Report

This past year has been an exciting and challenging time for Parish Council as we embraced a new format. Our dedication to communicating parish decisions and providing ministry within St. Paul's and to the greater community has not changed. However, our new format makes it possible for us to meet the requirements set out in our by-laws with less volunteer time and effort. As expected, we have experienced some growing pains as we adjusted to meeting quarterly and having two independent Executive Groups reporting to Parish Council, but I am pleased to say that no major modifications to the format as described at Vestry 2015 have been required.

The Ministry Support Executive Group was formed to ensure that communication would be maintained between Parish Council and the more than 50 independently-functioning ministries that we have at St. Paul's. This group includes a member of Parish Council, who serves as liaison between PC and the Executive Group. The Ministry Support group mandate, as outlined at Vestry 2015, is to:

- Maintain regular contact with current ministries
- Fill vacancies, transition leadership
- Address ministry issues as needed
- Communicate with Corp/PC, Ministries, and Congregation

The Priorities and Development Executive Group was formed to ensure that visioning and strategic planning would be given proper attention. This group includes a member of Parish Council, who serves as liaison between PC and the Executive Group. The Priorities and Development group mandate, as outlined at Vestry 2015, is to:

- Develop new ministry/activity proposals
- Conduct strategic planning around vision and mission statements
- Promote St. Paul's in the community
- Communicate with Corp/PC, Ministries and Congregation

The mandate of Parish Council is to serve as a committee of Vestry between annual Vestry meetings, receive financial reports (quarterly), and to approve the budget presented at Vestry. Parish Council is required to have the following members: priests, wardens, treasurer and Synod representatives. We also appoint someone to serve as clerk/secretary.

I would like to thank everyone who served on Parish Council this year, especially for their patience and support in this time of transition: Fr. John, Fr. Craig, Ken Miller, Elizabeth Vincent, Colin Mackenzie, Minx Mulhall, Mark Stalter, Jessica Dobson, Anne Baker, Lauren McCabe, Linda Keech, Zdena and Chris Harder, and Ed Gadd. A special additional thank-you to Minx Mulhall and Chris Harder for serving as PC Reps on the two Executive Groups.

I give thanks to God for His guidance, grace and mercy during the past year, and pray for His blessing on Parish Council and all those in leadership positions at St. Paul's as we continue to do His work.

<u>The St. Paul's Ministry Support Group</u> is one of two new executive groups formed this year, in order to address needs that were expected to arise due to the restructuring of Parish Council. The mandate of this group is to maintain contact with the ministries, fill vacancies, transition leadership within the ministries, address ministry issues and needs when necessary, and to communicate with the ministries, Parish Council, Corporation, and the congregation. Minx Mulhall is the liaison between this group and Parish Council.

Over the past year we were asked to work on a number of issues concerning the church, including finding a liaison from St. Paul's for Cornerstone (Linda Keech), and spearheading a spaghetti dinner and silent auction which raised over \$6300 for the Ruddy Shenkman Hospice down the road. We decided not to have an open house this fall for the ministries, opting instead to ascertain and communicate the functions of individual ministries and their specific needs in the New Year, to help plan in advance of Vestry in February, and to continue to increase the communication and visibility across the ministries. It's quite a change from the way things were done before, but we're excited about the path forward! The Priorities and Development Group (PDG) was given the mandate of looking 12 months or longer into the future and discerning where God is calling St. Paul's to go. Through a process defined by the group, the parish was asked to prayerfully consider what activities we are being challenged to undertake. The group was then to suggest the few focused activities that will help St. Paul's best fulfill its mission. This report is the culmination of this activity and will be presented for consideration to Parish council and Vestry 2016.

The process

The PDG identified current parish activities and examined them for themes and commonalities. They were then grouped into the following areas: 1. Personal Growth, Fellowship and Sustenance, 2. Outreach, 3. Our Building, 4. Our Money and; 5. Our People. Parishioners were asked to identify new ideas, search for themes

and discuss their importance. Four focus group evenings were held to discuss each of the 5 areas described above. Each focus group had the same rough agenda including a review of the existing activities (what's working and what's not), brainstorming new ideas, prioritizing ideas and looking at the filters by which the PDG would recommend activities to Parish council.

The results

The sessions were successfully held and, on average, 15-25 people attended each session. From the 4 sessions, 50 existing activities were evaluated and 131 new activities were proposed. Participants were asked to prayerfully vote at the end of each session and list only 3 new activities they felt the parish was being called to develop and 3 existing activities they thought the parish should rethink or re-evaluate.

The analysis

The ideas were grouped into 11 categories and ranked in order based on the number of votes they each received. The categories were: 1. Adult education, 2. Welcoming, integration and hospitality internally 3. Welcoming and hospitality externally, 4. Youth and families, 5. Seniors, 6. Pastoral care/prayer 7. Outreach, 8. Finances, 9. Communications, 10. Building and 11. Volunteers. The new activities were then further grouped based on similarities and a number of interesting themes emerged. These themes became potential programs that the Parish could implement and were prioritized based on the number of original votes they received.

The recommendations

The programs proposed were as follows: Hiring a youth and families activity coordinator (69 votes), initiating a parish small group program (52 votes), initiating a volunteers program (27 votes), initiating a refugee program (66 votes) and initiating a seniors program (27 votes). Finally, the PDG drafted potential implementation of the programs based on the filters and priorities determined at each focus group session.

The rationale

A focus on youth and families was determined as the most significant endeavor to be undertaken by the parish. Given that the organization of multiple youth and families based programs requires extensive coordination, it was felt by the PDG that this would be best accomplished with a full-time paid staff. Since the coordination of volunteer programs would also need to begin early on, the PDG proposed that the same staff person responsible for youth and families could also take on volunteer coordination. Developing small group ministry would ensure that new and existing parishioners are integrated and supported by close friends in the parish. Adult education, both in small groups and as a whole, would further our growth into the full stature of Christ. Ideally, the adult education in small groups and as a whole would complement and build upon each other. In addition to our internally-based activities focused on strengthening ourselves as a united body of Christ, we would reflect Christ externally by developing a coordinated program to integrate refugees from around the world into our community of Kanata and welcome them to our parish home.

Existing Programs

Existing activities were also examined and votes were cast based on the need to "reevaluate the effectiveness of an activity" or "consider stopping an activity". These results will require further deliberation and discussion in order to determine the best way to move forward. Nevertheless, the data gathered from the community indicated that the following activities should be reevaluated: 1. building and site maintenance, 2. gift campaign spending, 3. rentals, 4. volunteer soliciting techniques, 5. bulletin boards and communications and 6. Volunteer open house. The need for building and site maintenance is a clear priority as parishioners seek to keep the worship space beautiful and functional. The gift campaign funds could be directed towards some of the new programs discussed above. Rentals are a great source of revenue, but could our facilities be either used more by parish programs or to raise our profile in the community? How we solicit, train and retain volunteers as well as a reevaluation of the volunteer open house is discussed as part of the coordinated volunteer program.

Finally, communication strategies will need to be identified and implemented to help support the programs and mission of the church.

Moving forward

This report discusses each of the recommendations in greater detail. The data from the session is presented in appendices for people to study and evaluate as a tool moving forward. The PDG was tasked with running this activity and identifying these programs. It will be up to the Parish and Parish Council to decide which of the activities are implemented and when. Finally, it is our hope and prayer that these recommendation will bring about positive change at St. Paul's. The future of St. Paul's ministry holds much promise and excitement. Please consider how God may be calling you to participate and respond with "speak Lord for your servant is listening".

Bishop's Charge

Saying that this Diocese is blessed with significant ministries, able ministers and priests, devoted volunteers and committed parishes Bishop John Chapman opened the 134th session of Synod. He recalled Jesus' words to the invalid–"Pick up your mat and walk"–and challenged the Diocese of Ottawa to answer the call to new life, be alert and on its feet. Do not and wait for a purposeful and prayerful whole to emerge in the Diocese before making changes and doing new things, said Bishop Chapman.

Focus now, right away, on the little pieces, those small holy moments that make the Diocese buzz with relevance, hope and energy. At the Synod Eucharist, Bishop John asked Dean Shane Parker to install the Rev. Rhondda MacKay to the Canon of St. Andrew, and Rev. Jim Roberts to the Canon of St. George, and Ms. Monica Patten to become a Lay Canon of the Diocese. Bishop John thanked Stephanie Boyd and Kim Chadsey in their new roles as Communications Officer and Lay Secretary, respectively.

Guest Speaker: The Rev. Canon Dr. Isaac Kawuki Mukasa gave an inspiring address on "Custodians of the Faith in Secular Society."

Notices

Refugee Working Group: Don Smith, Chair, spoke of the current global refugee crisis. As a Sponsorship Agreement Holder, the Diocese is putting in place many new arrangements to respond to the crisis and to the interest of many involved. Sixteen parishes have now expressed interest in sponsoring refugees.

Parish Ministry Committee: Congregational Resource Day will be held on May 7, 2016 and will feature the theme "Embracing Hospitality: Open Hearts,

Open Doors." The Diocesan Youth Conference (DYC) is being held the long weekend in May at Christie Lake for youth aged 13 to 18, and the Canadian Lutheran Anglican Youth (CLAY) conference is being held the 17th to 21st of August 2016 in PEI for youth aged 14 to 19. For further information, please see the posters posted at the back of the church or talk to Jessica Dobson.

Reconciliation and Healing with Indigenous Peoples: Synod endorsed the Response of the Churches to the Truth and Reconciliation Commission of Canada and the ongoing work of General Synod, including the Primate's Commission on Discovery, Reconciliation and Justice. Synod also directed Council to further the work of reconciliation and healing in partnership with Indigenous peoples through building and maintaining of respectful relationships, diocesan education, and action.

Community Ministry Committee: Sue Garvey, chair of the Homeless and Affordable Housing, reported on the work of this CMS task force, whose purpose is to make recommendations for achievable goals in the area of homelessness and affordable housing, as raised at Synod 2014 when it endorsed the 2013 Joint Assembly resolution on the subject.

Finances

Diocesan Budget 2016: Peter Martin, Chair of the P&F Committee, spoke of seven ministry categories, and related expenses and revenues for each. The Parish Fair Share Task Force is working to simplify calculations and develop policies to deal with issues such as bequests, financial anomalies and parish amalgamations.

Future Financial Development: Synod voted to table for discussion until next Synod the following motion: that Synod endorse the Bishop's vision of an annual appeal and authorize Diocesan Council, in consolation with the Bishop's Financial Development Advisory Panel, to consider the strategic direction and budgetary implications of the annual appeal in the 2017-2019 budget.

Anglican Foundation of Canada: The Rev. Canon Dr. Judy Rois, Executive Director of the AFC, spoke about funding available to parishes for various proposals, including church renovations, accessibility issues, outreach projects and innovative ministry. Synod approved a motion to encourage parishes to enrol as members of the foundation. The Diocese may submit three proposals to the AFC each year, which are approved through Diocesan Council.

Divestment of Fossil Fuels: Synod approved the divestment of diocesan holdings in fossil fuel extraction companies, and approved the following motion: that Synod direct Diocesan Council to chart a course for complete decarbonisation of all the buildings of the Diocese that will involve measureable benchmarks and a defined set of actions.

EMBRACING SYNOD OR BEING EMBRACED BY SYNOD - Ed Gadd

A summary of the goings on at Synod has already been made available to the parish from your Synod Reps so I will not burden you with more of that but with an account of my personal impressions.

It has been several years since I have had the honour of representing St. Paul's at Synod. This year I experienced Synod in a different way than I had in the past. Rather than being a series of activities which were not necessarily interconnected I experienced a Synod in which there was, indeed, an interconnectedness of all the goings on: from the Bishop's Charge to the guest speaker (The Reverend Canon Dr. Isaac Kawuki Mukasa) to the Notices of Motion. I do not know whether it was that there was a different me at Synod or that this year's Synod was in fact different. Perhaps a little of both.

The message from Bishop John as received by me (perhaps not the same way by everyone) was that the church is unpredictable and not operating like Newtonian predictable physics but like the unpredictability of a type of quantum physics where the outcome of our actions may not be mechanistically predictable from our input - that the outcome of our actions or activities may not be as we expect or even occur when we expect it, but as God wants. This means that we must be faithful and expecting that God will honour our offerings but bring about results where and how God sees fit. This often calls us to go into the unknown of faith.

The most notable message I perceived from The Reverend Dr. Mukasa was that the church now resides in a secular society which is not familiar with the stories we all know so well. Phrases like "washed in the blood of the Lamb" and "King of Glory" do not have the same meaning to those who have not grown up in the church. In a secular society the mission of the church is known only through the activities in which we engage. In the current society we bring the story of God's love for his/her creation through our actions. This is the real teaching of our God.

This then brings me to the various presentations of the activities of our Diocese (and parishes) and the Notices of Motion. There were wonderful stories of the many activities in which we are engaged: our work with the homeless, with marginalized and disadvantaged women, with the aboriginal communities and with refugees, to name only a few. It is these activities which give to the world the tenets of our theology and mission. It is through these activities that the world gets to know our God and how we tick as a caring community.

That is why I said at the beginning that to me there was an interconnectedness of all the proceedings of Synod. I would urge all of you to become a St. Paul's Parish Rep. You would find it a very rewarding experience. Let your Parish Council know of your desire. You will get to know more about your Bishop, your Diocese and all the wonderful outreach activities we are supporting. You will also get to appreciate how much your Parish of St. Paul's mirrors the activities of the Diocese in faithfulness to the Gospel and mission. You would also get to spend time with members of your parish family. In addition, at every Synod I have been at as well as the standard coffee etc. a miraculous happening has appeared, some sort of confection. This may be brought by one of our Reps or this year it appeared after Father John was missing for a few moments. Coincidence, I think not.

I would also suggest that, in order for young couples with families to be able to be Parish Reps, we as a Parish family should request that child care be made available (within our Parish or at Synod) so that those young couples will be able to add their important voices to Diocesan activities.

So. Is it embracing Synod or being embraced by Synod? For me it was both.

Growing In Faith Together (GIFT) Campaign

Growing In Faith Together (GIFT) Campaign

Glory to God, whose power working in us can do Infinitely more than we can ask or imagine...

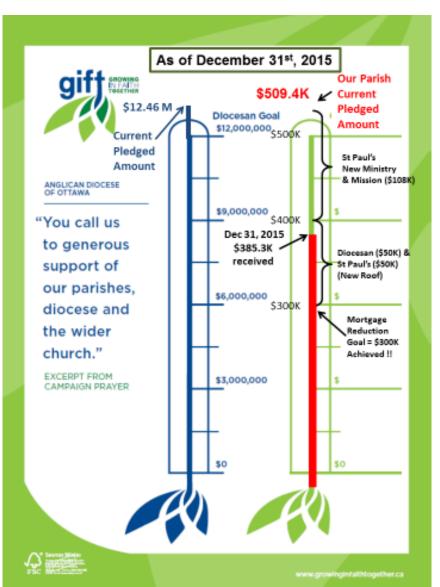
St Paul's GIFT program has passed the half-way mark – we celebrated the 3rd Anniversary of our 5-year campaign in November 2015. Our results have been exceptional, thanks to the generosity and faithfulness of our parishioners.

As of December 31st, 2015, our overall GIFT pledges and realized donations now total \$509,429. This is 127% above our original target of \$400K. Despite some anticipated pledge losses, it also represents a net increase of \$4.8K from our 2014 year-end position. As a Parish, we continue to visibly show our faith in supporting our mission and ministry programs.

Our partner in this GIFT Campaign, the Diocese of Ottawa, met and surpassed their target of \$12M by \$460K, thanks significantly in part to the success here at St Paul's. Many examples of what ministry GIFT has allowed the Diocese and Parishes to accomplish may be found continuously in the monthly issues of CrossTalk, the Diocesan newspaper, and on the Diocesan website.

In December 2014, we reached our first significant milestone, reducing our mortgage by \$300,000! As of December 2015, our mortgage now stands at \$571,000. (See detailed mortgage information in the financial portion of this Vestry Report).

Our second milestone was sharing the next \$100,000 on a 50/50 basis with the Diocese of Ottawa. To date, \$46,600 has been used to clear the loans for the new clerestory roof, as agreed at our Special



Vestry in September 2013. An equivalent amount of \$46,600 has been forwarded to The Diocese. As determined at the beginning of the GIFT Campaign, any funds raised over and above our \$400,000 goal will remain at St. Paul's in support of its ministry goals.

There have been several drivers over the last 2 years to assist St Paul's in determining how best to utilize the remaining GIFT program funding in the furtherance of our Vision and Mission in ministry. Clearly the first driver is the initial "Case For Support" for the GIFT program itself. It called for \$50,000 in funds to be associated with enhanced ministry for Youth, Seniors, and for Rutter Hall Air Conditioning (to facilitate improved facility usage and programming).

The second driver was the 2014 Community Consultation exercise which resulted in a number of community needs for St Paul's to consider as a way of enhancing its presence and ministry in Kanata.

As this GIFT Vestry Report is being written, a 3rd initiative is just wrapping up which will provide St Paul's with strategic recommendations and priorities for Parish Council and Vestry consideration. A series of Focus Groups was held this past fall to solicit parishioner input in support of our strategic way forward. The resulting summary report is available elsewhere in this Annual 2016 Vestry Report. Together, these 3 drivers (Case for Support, Community Consult, and Strategic Focus Groups) will allow Parish Council, and ultimately Vestry, to assess and discern where St Paul's should best choose to allocate its resources (financial, facilities, and people) to enhance and expand its ministry.

The GIFT Campaign still has 2 years to go. If you are new to St. Paul's, have not yet contributed, or would like to make an additional contribution, it's not too late! Our mission and ministry will continue to depend on the generosity and faithfulness of all our parishioners. We have GIFT Campaign brochures available (just ask one of the undersigned co-chairs or the church office) which provide additional detail concerning GIFT.

The GIFT Campaign is a large and complex undertaking requiring significant diligence to maintain proper accounting and administration. As GIFT co-chairs, we express our continuing gratitude to our treasurer, Mark Stalter, our envelope secretaries, Bob & Nancy Moxley and their counting team, and especially to Wayne Keech, our GIFT Campaign administrator for helping to keep track of every GIFT pledge and donation.

We are blessed at St Paul's to have such a wonderful community of committed parishioners who so willingly and sacrificially give of their time and their resources to further our delivery of ministry both within and beyond our church walls. We all should be very proud of what we have accomplished in this parish, and very thankful that God continues to bless us with the desire and ability to respond to His Call in such a meaningful way.

Praise God from whom all blessings flow....

St Paul's Men's Group – Gordon Anthony

St Paul's Men's Group is an adhoc organization under chairman Gordon Anthony.

The Men's Group supports the parish with labour by the Barn Raisers, whether it is for spring cleaning or support of the Christmas Bazaar or any other activity. Gord Walt runs the Barn Raisers.

In July 2015, approximately 18 men of St Paul's took part in an outreach mission to paint the Anglican Church at Maniwaki. The mission was organized by Ray Brule and Fr John Bridges, and involved a two-day effort to scrape and paint two sides of the church, as well as extensive repairs to the boardwalk.

Three years ago the Barn Raisers took on an outreach activity where we are responsible for one of the cabins at the Waupoos Family Farm. This charity provides a get-away or respite for under-privileged families. Many hours have been spent on repairs and maintenance, and more work is planned for the upcoming summer.

We hold two or three Saturday Morning breakfasts annually, with guest speakers, which attract around 30 men. In February, Adrian Fisher gave a talk on his pilgrimage hike on the Camino de Santiago, Spain. Adrian described the experience, hardships, and joys of completing this arduous journey across northern Spain to the Cathedral of Santiago de Compostela in Galicia. At a breakfast in November, Brian Hull, from the Ashton congregation, gave a talk on his experiences in the Anglican Church from his childhood to present day. He reflected on the many changes that have taken place within the Anglican Church during those years. We are looking forward to our next Men's Breakfast on Feb 20, 2016, when Jeff Upton will give a first-hand talk on life in the visually impaired community.

All men are encouraged to join us for any of our activities or to bring new ideas forward to help the men get more involved in the ministries of the parish.

St. Paul's Quilting Group - Joan Ferrier

St. Paul's Quilters meet in Rutter Hall on Tuesday mornings from 9:30 a.m. to noon from September to June. At present we have twelve regular and 2 "occasional" quilters. Outreach & Mission Report – Bill Ranger

Mission & Outreach has a number of programs areas including support to the Kanata Food Cupboard, Primate's World Relief and Development Fund (PWRDF), Refugees, Centre 454 and The Well. These programs were led by Heather Colls, Philippa Wilson, Lauren McCabe and Bill Ranger respectively.

With the recent cold snap volunteers at the various centres were very glad to receive the latest 193 items donated. Items included socks, scarves, toques, gloves, ear muffs, slippers and even some knitted baby items and dolls. Some of our street friends commented and were very appreciative of the delivery of a new supply of warm, dry socks and clothing. Thanks to all who helped to show through you that the Lord does provide and care for those in need. Our total for the "Sock it to Me Program" to help our own local urban refugees was 238 items. Hopefully the Lord will bless and keep us for our ongoing support.

OUTREACH 2016 July Nicaragua SchoolBOX International.

We can officially confirm that 5 members of St. Paul's and 4 members of St. Thomas' Stittsville will be travelling to help with School Build Project: MIRNA MARTINEZ School in Masaya, Nicaragua. From St. Paul's Lorna & Ray Brule, Janet Tonks, Marsha Fisher & Cathleen Reid.

Over the next few months you will be invited to some special activities to help raise money for this project. This visit was originally planned in May but it simply proved too difficult to find the time and volunteers for those 10 days.

While initial interest from St. Paul's looked as if we could field 2 trips; I am both thankful and hopeful for my 4 travelling companions. And I pray that the five of us, by going first, will become enthusiastic cheer leaders for future mission trips.

Cornerstone Housing for Women – Linda Keech, Cornerstone Housing Rep

In June of this past year, Cornerstone needed our help as their government funding had been cut drastically. We at St. Paul's rose to the occasion by giving money monthly to support them. We were instrumental in getting them through the crisis. Also, in December, we had a food drive so that the 40 women there could participate In Christmas baking. Once again, it was heartwarming to deliver all the goodies you at St. Paul's provided. Thank you so much for your caring and support of this ministry. In the spring of 2016 I hope to do another food drive for vegetables and fruit that their diets require.

Kanata Food Cupboard Volunteers - Heather Colls St. Paul's team lead

The Kanata Food Cupboard is an outreach of St. Paul's Anglican Church. It is located in the basement of our church. The Kanata Food Cupboard is run by an elected board of directors.

St. Paul's Anglican Church has a team of volunteers that give a week every six weeks. They help clients shop for food, pack food and deliver food for those unable to get to the Kanata Food Cupboard. We are always looking for new volunteers. If you have 2 ½ hours every six weeks, that is all we ask for. We arrival at the Kanata Food Cupboard around 4:45, clients start coming at 5 and it depends on how many families we have how late we stay. The deliveries start at about 5:30 p.m. going out from the Kanata Food Cupboard.

PWRDF - Philippa Wilson

2016 was a year where there was much reflection on our First Nations communities and on refugees.

On Saturday April 18, 2015, Jim Holt, Sandra Cooper and I attended The PWRDF Workshop "Sow much Love...Enough for All", which reflected on opportunities to learn more about global issues and local opportunities to provide initiatives towards food security. We heard about Valerie Maier's trip to Cuba and how the diocese of Cuba is encouraging the use of sustainable agricultural practices to provide food security for Cubans. Philippa Jones from All Saints Westboro explained how their church is using available space to grow vegetables to support local food banks and there was discussion on how churches can use their land to support such initiatives. There was some discussion on the availability of food and the obstacles to food security in our northern territories.

The early months of 2015 was spent by the Diocesan PWRDF Working Group working with other churches, preparing for the final report of the Truth and Reconciliation Commission, in Ottawa on June 2, 2015. How could we educate our communities on the impact of residential schools and how that impact is reflected in many of the problems encountered by our First Nations communities today? How could we respectfully support our First Nations communities as they shared their stories? Parishioners were encouraged to participate in the events surrounding the release of the report. Our Sunday School made a heart on a stick to be part of the ceremonies at Rideau Hall to honour the residential school children.

Our PWRDF Diocesan Working Group, participated in the planning of Covenant Chain Link VI, held in October. Organized by PWRDF partner KAIROS, ecumenical, aboriginal, individuals and groups, this workshop brings together aboriginal and non-aboriginal people to learn together about the ways in which we can move towards new understanding and relationships.

In October 2016 members of our diocese joined our PWRDF team cycling in the Ride for Refuge to raise funds for PWRDF's partner Refuge Egypt, who are assisting displaced Syrians seeking safety in Egypt.

At St Paul's we have responded to appeals for a number of emergencies. The devastating earthquakes in Nepal killed more than 7,000 people and displaced more than a million. PWRDF worked with our partners to provide for the immediate needs of the survivors and assisted in the rebuilding of villages. Here in Canada, the Saskatchewan Wildfires necessitated the evacuation of over 12,000 people. PWRDF disbursed funds to the Prince Albert Grand Council (PAGC), which represents 12 First Nations. PAGC provided meals, clothing, and shelter to supplement the Red Cross' efforts, as the needs had overwhelmed the Red Cross' capacity to respond. PAGC also helped to transport and provide medical care to evacuees and supported the firefighters battling the wild fires.

From September onwards, our attention has been on the crisis in the Middle East and the ongoing violence in Syria. This has displaced 8 million people, over 4 million into neighbouring countries and many trekking thousands of miles under hazardous circumstances to seek safety in Europe. PWRDF began relief efforts in 2011 and throughout this time money has been going to our partners including the Act Alliance and Canadian Foodgrains Bank to provide food, shelter, education and psychosocial counselling for the many people seeking assistance in the countries neighbouring Syria. Food and clothing has also been distributed by our Act Alliance partners in Europe as they encounter refugees crossing their own national borders. As we welcome Syrian Refugees to Canada, millions of Syrians will never be resettled but will remain as refugees either in Syria or in neighbouring countries. We pray for a peaceful resolution and continue to support our partners working in the difficult circumstances of the refugee camps. Since Sept 12, 2015 when the Government announced that it would provide matching funds to donations for relief efforts in and around Syria, Canadian Anglicans have donated \$488.605.

In December, I sent \$120 to PWRDF as proceeds from the sale of PWRDF Christmas cards. Thank you to all of you who bought cards, especially those of you I see every year!

A special thank you to all the parishioners who are regular PWRDF contributors throughout the year and then dig further into their pockets to support PWRDF appeals. I am always heartened by the generosity of this parish.

The Kanata/Stittsville Refugee Sponsorship Group (KSRSG) - Lauren McCabe

Submitted below is the year-end report from the Chair of the KSRSG

The Kanata/Stittsville Refugee Sponsorship Group (KSRSG) formed in 1996 with seven member churches, (Kanata, Stittsville and Glen Cairn United, St. John's South March, St. Thomas, and St. Paul's Anglican and St. Andrews Presbyterian). We sponsor refugees from around the globe to provide them with a safe haven and the opportunity for a new life in Canada. For those whom we sponsor, we provide financial, social, emotional and logistical support for their first year in Canada. Our funding comes from the annual pledges from member churches and occasional fundraising activities. This is part of what we accomplished in 2015:

- 1. Syrian Refugees: The terrible plight of those fleeing war and oppression in Syria has gained a great deal of attention in Canada and around the world. Throughout the fall we received many inquiries about what we were doing about the situation, as well as offers of support. At the time of writing this report, we have submitted a refugee sponsorship application for a single female from Syria with relatives in Stittsville, and await news regarding the status of her application. We are also in the final stages of completing a refugee sponsorship application for a single male who also has many relatives here in Ottawa. We hope this application will be submitted within the next week. In addition to these two sponsorship applications, we are also planning to sponsor another family who would be suggested by a Canadian government process, however to date we have not been successful in obtaining the name of a family to sponsor. We appreciate all the support being offered, and will provide regular progress reports. Trinity Presbyterian Church in Kanata has also expressed interest in working with us to sponsor refugees from Syria.
- 2. **Rwandan Siblings:** We continued to provide financial support to four siblings living in Rwanda who were orphaned during the Rwandan genocide in 1994. We have been committed to support them until they have each obtained a post-secondary education. Three of the four siblings have reached a point in their education such that we will no longer be providing them with financial support. We will continue to support the fourth sibling for another year or two.
- 3. **Families from Afghanistan:** Some time ago we submitted sponsorship applications for two families from Afghanistan who are presently living in Tajikistan and who have family members here in Ottawa. We were informed in June 2015 that the families had been interviewed and approved, and though we have sought further information from immigration officials, we have not received any additional contact regarding when the families might be arriving in Canada. With the support of other members of the Afghan community here in Ottawa we completed and submitted a sponsorship application for a family from Afghanistan who are presently living in Dubai. We have not had a response from Canadian immigration officials regarding their status.
- 4. Family from Iran: We are working with family members here in Ottawa to complete a refugee sponsorship

application for a family from Iran. We hope to have this application submitted early in 2016.

5. **Ride for Refuge:** We participated in this annual bicycle fundraising event held in Kanata in October, from which we received almost \$5,500. We thank John Toft of Glen Cairn United for all of his assistance.

In 2016 we will continue to monitor the progress of the sponsorship applications mentioned above, and seek to sponsor an additional family from Syria. We have also offered to support another church in sponsoring a family from Iran. We will assist as many refugees as our resources permit.

We wish to thank everyone who contributes to and supports the work of the KSRSG including those who have attended KSRSG meetings on behalf of our member churches.

Adult Education Vestry Report



THE CHALLENGE!

God's Word transforms lives and transforms churches! It was for this reason that St. Paul's undertook the E100 Bible Reading Challenge a little over a year ago. This program was developed by Scripture Union to get more people reading the Word of God. The challenge is based around 100 carefully selected Bible readings (50 from the Old Testament and 50 from the New Testament) designed to give participants a good understanding of the overall Bible story from Genesis to Revelation. The 'E' stands for Essential and each of the Essential 100 readings ranges from a few verses to a few chapters. In November of 2014 over 180 parishioners accepted the challenge to read these passages over the span of 50 weeks. What a blessing it has been!

We started the year with a "Blessing of the Bibles" Sunday in November 2014 where parishioners committed themselves to the challenge and asked God to bless their reading of His Word. Participants ranged from those who had never read the Bible to those who were well versed in it. Individuals, couples, family groups and small groups read the selected passages over the course of the year. In an effort to help keep people on track and engaged, weekly readings and discussion questions were posted in the hall and emails were sent out to participants. In addition to the private reading, we were blessed by a variety of speakers who shared their thoughts and reflections on the passages during adult education evenings which were organized periodically throughout the year. It was amazing to have so many people, both from outside and from within our own community, come along side us on this journey. These educational evenings with coffee, tea and desserts gave participants a chance to delve into the readings, as well as a forum for learning God's Word in fellowship and community.

As we moved forward in this journey, promotional materials were featured regularly in the Cornerstone newsletter. This allowed information to be shared with participants and the congregation at large, and for participants to share their experiences with each other. Additionally, a Minute for Mission was presented in June to help keep participants motivated moving into the summer months and to welcome new people to join in the challenge.

The blessings for our church community have been many. Participants have wrestled with passages that they may otherwise have avoided, and have found encouragement and comfort in the Word of God. Fellowship and sharing stemming directly from this program have helped to strengthen our church community. Perhaps most importantly, through completing the challenge, participants have been encouraged to build a regular habit of spending time with God through Bible reading and prayer.

Now that the program has ended, we are sharing our experience with others. We have had E100 articles in the Cursillo Rainbow newsletter and Ottawa Diocesan Crosstalk newspaper. We are also meeting and discussing our experiences with other congregations to help them as they seek to launch their own E100 programs.

EFM Program - Dot Sweeney

EFM is Education for Ministry. It is theological education for ordinary Christians. It is not bible study.

Two members of St. Paul's started on that journey last year, held at St. Thomas in Stittsville. Presently we are 7 students: 3 in first year and 4 in second, guided by two mentors. We meet once a week for two half hours from September to the end of May. We commence and end each session with a short worship service on rotation of members, followed by a brief check in as to how our past week has been.

There is a set curriculum that we follow with themes for the year. This year's theme, is 'Living as Spiritually Mature Christians'. Each year has their own readings, questions to ponder pertaining to what their readings are and then all years to respond to 'theological reflections'.

The program is four years: The Old Testament is done in the first year, second year The New Testament, in third year Church History is studied and the final year covers Theology, Ethics and Interfaith relations.

There are also two 'interludes', one during the fall and the other in the spring whereby we read assigned books that add to what we are learning and discussing. One read last year was Globalization, Gender, and Peacebuilding. Our group has just finished reading, Jesus and the Disinherited. These books are part of the curriculum for the year.

The program requires commitment of time for the weekly reading and attendance. But there's a lot of fun,

humor and fellowship that occurs along with ongoing personal growth, and learning to how to integrate all of this into our lives. It is not essential to have a biblical background or even have taken a bible study class. All that is required is a commitment, an open mind, an open heart and a willingness to come away knowing a little more than when you entered.

Sunday School/ God Squad - Tracy Albert

2015 was another fun-filled and educational year for the kids at God Squad. We were blessed by the efforts of several volunteers, who gave of their time to make a difference for the children. The year began with an Epiphany party in January, followed by our Super Hero party in February, both generously hosted by Joyce.

We heard about how to make the lessons fun, educational, and how to reach children of a variety of ages. Building and Site Maintenance – Steven Shamess

This was quite the green Christmas; at least we had all parking spots available. I was contemplating cutting the grass at the front of the church for the Christmas Eve services. And then it snowed less than a week later. Good thing we have the snow clearing contract.

Every year I talk of lights and how many I replace; I have begun the process of replacing the CFL flood lights that happen to burn out with LED Flood lights. The cost has dropped down as I was purchasing them for \$20 a bulb in the fall. These bulbs are comparable to the price of CFL but offer an increase in light output 1500 lumens vs 1300, lower wattage 18 watts vs 23 and longer life 25,000 hours vs 8000.

We currently use HID lighting in the two main areas; I have looked into replacing these with LED lighting. However, the LED replacement cost remains 7x that of the HID. Some rework of the electrical would be required to remove the ballast out of the circuit as the LED bulbs have a built-in ballast. HID lights have a much higher light output than the LED replacements. The new HID bulbs we use produce 40,000 lumens and over the life of the bulb drop down to 10,000 lumens; LED bulbs consistently have 20,000 lumen output. When the price-point is more favourable I will make the switch to the high intensity LED blubs.

Gordon Ripley did a nice job repairing and replacing the floor tiles at the ceremonial entrance and the north entrance. The design of the doorway specifically the threshold allows for air and moisture to attack the tiles

where they meet with the aluminum threshold. Unlike a private home where the threshold is higher than the floor, sealed to the outside and angled to drain outwards we have a flush threshold to allow for ease of access.

A de-icing cable has been installed at the Sacristy entrance to reduce icicles. I will observe the effectiveness and adjust where necessary to reduce icicles and prevent the water leakage we have last winter due to an ice dam. This brings us to what plans there are in the future.

Ongoing maintenance will the major time consumer as the ceiling near the stairs has to be repaired due to a water leak. One of the furnaces has, what I believe is, a relay issue where the furnace will continually run and not cycle appropriately. I will bring this up with our external HVAC service team.

We are halfway thru the life expectancy of the furnace. We have 5 furnaces; two large ones and three small ones. We have had to replace the electronics on two of the furnaces so far. The roof over the hall and kitchen area is, also, past its half life. There is a need to set aside capital for the next 10 years to accommodate these major expenditures. Lastly, since having the walkway replaced over the food cupboard entrance with typical deck wood the water drips down on top of those underneath. The solution is to prevent moisture from getting onto the walkway by way of an overhang above the walkway. This would push the moisture further out and exasperate the issue of soaking those below with a concentrated flow off the roof of the overhang. So as you can see some forethought will have to go into the solution whatever it maybe for this capital project.

ENVELOPE SECRETARIES - Bob & Nancy Moxley

There were 336 identifiable givers in 2015 (328 in 2014) who gave an average annual giving in 2015 of \$1,116 (\$1,113 in 2014). Identifiable givers are parishioners giving \$25 or more in the year to the General Fund.

At year-end 2015 there were 130 parishioners using the Pre-Authorized Withdrawal (P.A.W.) program, unchanged from the end of 2014. Offering envelope boxes for 2016 were issued to 176 parishioners, again unchanged from 2014.

Envelopes continue to be available to those parishioners who wish them. We have encouraged the use of the P.A.W. program in several ways throughout the year. The P.A.W. program is a convenience to both the parishioner (no envelope to remember on Sunday or makeup after vacation) and to St. Paul's (a consistent, identifiable cash flow). Applications for the P.A.W. program, as well as a "Revision Form" for current P.A.W. participants, are available on a table in the Narthex (front foyer) of the Church or from the Church Office. A signed Application (with a voided cheque) is required to start or a signed Revision Form is required to make a change to your donation amount. We (Bob or Nancy) would welcome any questions about this program and would be pleased to explain how easy and secure it is to donate in this manner.

We would like to thank the counters for their valuable assistance over the past year. Their help is much appreciated by us and by St. Paul's.

Gift Certificate Program 2015

There were a lot of changes in the program this year with a number of changes in the administration. After many years of faithful service Darrell Small stepped down from the responsibility for the program. We thank him for his work and faithful service.

St. Paul's along with Christ Church Ashton, St, Thomas' Stitsville, St. Stephen's Ottawa and St. Paul's United Church, work together to get the highest discount available. The group combines their resources to purchase Gift Certificates from Loblaws, Farm Boy, Sobey's and Food Basics (Metro). We purchase gift certificates with a 5% reduction and then sell them to parishioners for face value. Parishioners get a dollar for dollar value and the churches get a 5% bonus. This year the Gift Cards made a profit of over \$10,400 for the operating budget of Saint Paul's.

Thank you to those who use the gift cards, those who sell them each week, and to Tracy and Bob Albert who do the books. We are in need of a new Coordinator to manage the floats and do the ordering and distribution of the gift cards (which takes 2 hours a week).

I believe that the use of this program could grow and increase our revenues without costing the parishioners any further expense.

Treasurer's Report

What can be said about a year that we finished in the black except, praise the Lord.

I have said before that I approach the finances with one cardinal rule, be consistent. Whether that consistency is in remaining a fiscal conservative until the last possible moment, or in delivering the message of "we did what we said we would do" I believe that it is important.

The 2015 financial year was fairly predictable. Historically we start off slow in a new year. We have an increase in the spring and we finish the year strong. If we could flatten out the peaks and valleys, well I know of one treasurer that might relax. We have been blessed and there was a sense that God was providing enough manna allowing us just enough so that we were never playing catch up. While we did not meet budget targets we as a parish kept expenses under control and we did see a growth in receiptable income.

Our receiptable income (envelopes, capital campaign was 98% of budget. Envelope offerings had 2% year over year growth. Our other income category certainly bolstered the bottom line. We realized significant increases due to the streamlining of the gift card program, redemption of a trust fund that had come due this year, and an unexpected increased HST refund. It is important to note these numbers are significant achievements as the 2015 revenue numbers were certainly stretch goals.

I wish to thank the numerous organizations who made significant financial gifts to the church. The Bazaar, Quilting group, Chicken Bar-B-Q, and the Gift Certificate program have all contributed to the finances of St. Paul's. Our rental coordinator, Lorna Brule, also deserves a vote of thanks for managing the rentals this past year. Our bottom line is significantly affected by the faithful work of these groups and individuals.

Cash Flow:

There is really only one item that people might question with the above snap-shot: People and Outreach: The amount reported included the funds from the gift program that were disbursed to the diocese. This represented approximately \$45,000 of the total. Additionally the Maniwaki project which was essentially a pass through of the directed donations.

One of the vehicles to help with forecasting is to achieve greater participation in the Pre Authorized Withdrawal, or PAW program. Currently 55% of our envelope income is realized through the PAW program.

For St Paul's community to have the greatest impact, we must continue to make spending decisions with a clear view of the modified mission of St. Paul's. With our focus now on worship, teaching and equipping we must be purposeful in our relationship with Christ and accept the commitments to make our mission a reality.

It is a fairly common statistic that 80% of our funding comes from 20% of the people in our church. Though some experts are seeing the trend move to 90/10 ratio in giving. The startling statistic for me is that the rest of the funding comes from only 30% of the congregation. Recent studies have stated that 53% of Christians have not given to their church in the last month.

2016 is the last year of our reprieve on our loan commitment to the diocese. Debt is not exciting, it is not a roof, it is not a lift, and yet we are obligated to begin paying this commitment at the beginning of 2017. This will represent a \$4,000 +/- monthly payment. Any efforts to reduce this obligation while we are in interest free mode will have a significant impact in next year's budget

There is no doubt that we have much to be proud of. We continue to be blessed in our journey, the driving factor in our decision to rebuild, to be part of community. We have many opportunities ahead of us that we should all look forward to with joyful expectation.

We have over the last 10 years been blessed with a financial position that many parishes do not share. With this track record come certain expectations. We must all remain committed to the challenges that are ahead. We can do all things through Christ who gives us strength.
